Kilang, rumah pekerja curi air diserbu

SEREMBAN - Sebuah kilang kayu dan rumah pekerja di Batu Kikir, Jempol, diserbu Syarikat Air Negeri Sembilan (Sains) dan Suruhanjaya Perkhidmatan Air Negara (SPAN) selepas disyaki membuat penyambungan air secara haram.

Ketua Bahagian Perhubungan Awam Sains, Norzita Ismail berkata, serbuan dilakukan pada jam 11.30 pagi Khamis lalu itu diketuai pegawai SPAN, Muhammad Nazwan Sanin dari Bahagian Siasatan dan Penguatkuasaan SPAN dan Unit Penguatkuasaan Sains.

Menurutnya, siasatan di lokasi mendapati penghuni premis melakukan penyambungan tidak sah tanpa melalui sebarang meter air bagi kegunaan harian pekerja, mencuci tayar kenderaan, kegunaan di pejabat serta kawasan kilang kayu tersebut.

"Ujian klorin di lokasi berkenaan terbukti bahawa bekalan air yang digunakan ialah air terawat milik Sains," katanya dalam satu kenyataan kepada Sinar Harian hari ini.

Menurutnya, kes disiasat mengikut Seksyen (89)9 Akta Industri Perkhidmatan Air 2006 dan jika sabit kesalahan boleh dijatuhkan hukuman denda sebanyak RM50,000 atau penjara tidak melebihi enam bulan atau kedua-duanya sekali.

Pihak SPAN turut menyita semua pemasangan dan punca sambungan yang dibuat sebagai bahan bukti.

Sementara itu katanya, syarikat itu terus mempertingkatkan pemantauan serta penguatkuasaan terhadap kegiatan curi air di negeri ini tanpa mengira sama ada untuk tujuan komersil atau domestik.

"Tindakan tegas ini merupakan salah satu langkah berterusan dalam mengurangkan kadar kehilangan air tidak berhasil (NRW).

"Orang ramai yang mempunyai maklumat atau ingin melaporkan sebarang kes curi air boleh menghubungi talian bebas tol Sains 1-800-88-6982," katanya

PUNCA SAMBUNGAN AIR SECARA HARAM

The board factory is suspected of stealing water.

(Furong 25th News) It takes a painful minute to steal water for every minute! A board factory was found to be suspected of stealing water by a law enforcement unit. Once the crime was committed, it could be fined 50,000 ringgit or imprisoned for no more than 6 months, or both.

BATU KIKIR

The board factory suspected of stealing water is located in Batu Keiki, Renbao **NEGERI SEMBILAN** County. After receiving the information, the Senzhou Water Company and the National Water Service Commission (SPAN) went to the relevant location to initiate a ban operation.

The banning operation was carried out at 11:30 am on June 18, the board factory was found to be illegally connected to the water pipe, stealing the purified water produced by Mori Water Company for daily use by factories, offices and workers, and also used for cleaning traffic Tool tires.

The National Water Services Commission will invoke the investigation of Article 89(9) of the 2006 Industrial Water Supply Service Act and confiscate all water pipes that illegally connect to stolen water as evidence.

Mori Water Co., Ltd. emphasized that it will try its best to combat water theft to reduce the rate of non-revenue water. The company also urged the public to continue to act as eyes and ears. If they find any water theft, they can report or provide information through the hotline 1-800-88-6982.
